- FACILITY:** Competition Pool: One 50-meter pool with ten-7.5-foot wide lanes each with non-turbulent lane markers. Daktronics 2000 Time System will be used. For Friday and Saturday nights and Saturday/Sunday mornings, lanes 1-9 will be utilized for competition, with lane 10 reserved for warm-up and warm-down. For Saturday/Sunday afternoons, there will be no separate warm-up/warm-down facilities. In the event of circumstances necessitating changes during the meet, information will be updated on the FAST website at [www.fasttigers.com](http://www.fasttigers.com). Balcony spectator seating is available.
- PARKING:** Free parking will be available in the lots adjacent to the Fishers HS Aquatic Center.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern the meet. Please pay special attention to rule 202.3.2 that states, "At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition and warm-down. The Meet Director or Meet Referee shall assist the member in making arrangements for such supervision.
- ELIGIBILITY:** Age as of May 16, 2008 shall determine the age for each swimmer entered into the meet. All swimmers must be registered with USA Swimming. These registration numbers must accompany entry. Coaches must constantly display their USA Swimming coach credential to gain deck access. The meet referee or meet director reserves the right to ask for coach credential display and/or deny access if the coach does not comply.

**MEET FORMAT:** All events are **TIMED FINALS**. This meet will be run with split sessions on Saturday and Sunday. **The Friday evening session consists of the following age groups: 11-12, 13-14 and Open events. The Saturday evening session consists of the following age group: 11-12, 13-14 and Open 1500 Free. The Saturday and Sunday morning sessions consist of the following age groups: 13-14 and Open events. The Saturday and Sunday afternoon sessions will consist of the following age groups: 8 & Under, 9-10 and 11-12 events.**

The Fishers Area Swimming Tigers reserves the right to **limit the number of heats in all events to keep the time line manageable**. There will be refunds for a swimmer not making the top heats. Limits will be posted to the Fishers Area Swimming Tigers website on Tuesday, May 6, 2008.

If a swimmer misses their event, they will be declared a “no show” and will not be placed in any other heat to make-up the swim.

Fishers Area Swimming Tigers reserves the right to use or “fly-over” starts for all events.

**NOTE: Age groups 13-14 and Open will compete together, but be awarded and scored separately. The 8-Under and 9-10 Age Groups will swim together but be awarded and scored separately.**

**POSITIVE  
CHECK-IN:**

Positive check-in means, “I am here and I intend to swim this event.” All events 200 Yards and under will be pre-seeded. There will be a positive check-in for all events that are 400 yards and over. Check-in will close 45 minutes before the session start time.

Positive check-in sheets will be located at the security tables as you enter the pool area from the lobby on the deck level. All swimmers not declaring intent to swim the events that are 400-meters and longer via positive check-in will be scratched. Since the number of heats will be limited on Friday and on Saturday for the 1500-Meter Free, failure to check-in may jeopardize your opportunity to swim your events. **The 1500-Meter Free will be swum from fastest to slowest alternating one heat of girls with one heat of boys.**

**ENTRIES &  
LIMITS:**

No team entry will be broken. Each swimmer will be limited to four (4) individual events per session. If an entry is submitted with an individual entered in more events than this rule allows, the entry will be made by order of events starting with Event #1 until the rule is satisfied; there will be NO refunds.

FAST reserves the right to determine which entries to accept. Among the items FAST and will consider when making these determinations are: teams will not be broken, number of officials and volunteers provided by the team, balance of age group and gender in entry, level of competition and geographic location.

The Fishers Area Swimming Tigers reserves the right to **limit the number of heats in all individual events to keep the time line manageable**. There will be refunds for all swimmers that get cut out of events.

**EVENT SEEDING:** All events 200 Meters and under will be pre-seeded. There will be a positive check-in for all events that are 400 Meters and over. Check-in will close 45 minutes before the session start time.

**ENTRY FEES:** All fees **must** accompany entry. Please make check payable to: **FISHERS AREA SWIMMING TIGERS**. Individual events are \$4.00 per event.

There is also a \$1.50 per swimmer, per meet, Indiana Swimming surcharge which must accompany entry.

**DECK ENTRIES:** Will be accepted if the meet is not filled on **ONLY** as **NEW ADDITIONS**; **CHANGES WILL NOT BE ACCEPTED**. Entry fee for deck entries are \$10.00 per individual event.

**DEADLINE:** All times must be submitted in **LONG COURSE METERS TIMES AND COMPLETED TO THE HUNDRETH OF A SECOND. CONVERTED TIMES MUST USE THE HY-TEK TIME CONVERTER**. Times may not be updated after the entry closure date of May 2, 2008. Please enter each swimmer with their first and last names, age and USA Swimming number on the entry. **Entries will be accepted immediately. The final entry date for entries to be received is 5:00 PM on May 2, 2008 or when the meet is full, whichever is later. Teams not accepted will have their entries returned as soon as possible, but no later than by May 5, 2008 via email or US Postal depending on the form of entry.**

The entry deadline will be extended if the meet is not full. Email confirmation of receipt will be returned. All email entries must be followed by a paper entry and check for entry fees. Please make your check payable to Fishers Area Swimming Tigers and enclose it in your entry. The meet will be run using Hy-Tek Meet Manager computer program (do not forget to “age up” swimmers to 5/16/08).

A printed copy of your meet entries must follow your submission of your entries via email. **In all cases, the printed copy is the final word in any disputes involving entries.** Entries not submitted via email will be subject to a \$50.00 data processing fee.

**OFFICIALS:** The Fishers Area Swimming Tigers will need the help of your **USA Swimming Officials**. If you have a member that is in charge of your officials, please provide his/her name & email address on the entry summary form where requested.

**FACILITY NOTE:** The Fishers High School Aquatic Center is one of the most beautiful high school facilities in the USA. It is important that all people attending this meet, whether it is swimmers, coaches, or spectators, treat this facility with the utmost care. The following rules will be strictly enforced:

1. Keep all trash picked up (swimmers and teams in particular).
2. Do not go, or let children go, in any unauthorized areas. This means any place other than the lobby or seating areas. Due to USA Swimming insurance requirements, **only** swimmers, coaches, officials and volunteers are allowed on deck. **There can be no exceptions!**
